- **Only entries delivered by USPS First Class Letter will be accepted. No other entries will be considered.**
- **Entries will only be accepted with a WCR registration number.** To obtain an immediate, temporary, Rally registration number online, please see: "Web Addresses" on the next page of this premium.
- **Important: Please be sure to enter all digits of your Rally Registration Number correctly!**
- **Acknowledgment of entries** will be sent by e-mail.
- **Confirmations** will be sent via e-mail after the closing date or when limits reached.
- **Closing Date: Entries close September 1, or when limits are reached. No refunds after closing date.**
- **As a courtesy, run orders will be available on our web page close to trial date. Please check the gate sheet at the trial for official running order.**
- **Move-ups between levels** will be allowed until 5pm October 10, 2016, via e-mail. Move-overs from the A class to the B class are mandatory for teams who earn titles on date of trial, and will be made day-of trial by the show secretary.
- **Inclement weather information (e.g., change in trial start time) will be posted on our web site by 8PM, September 30, 2016**
- This is an indoor trial. Folding chairs are available, but please feel free to bring your own.
- **FOOD!** Snacks and our famous fresh lunch buffet will be available.
- Refrigerator/freezer and microwave are available for your use.

First left to Ferris Avenue, under I-287 overpass. We are the first two-story red brick building on right (PCOTC sign on side of building). Entrance is at the rear of the building, down the driveway between 230 Ferris and Condon Lumber.

From West: Interstate 287 (Cross Westchester Expressway) to Exit 6. Right off ramp onto Route 22. First right onto Westview Ave. After left curve, turn right to stay on Westview, down hill. Left onto Ferris Avenue and proceed as above.

You may park in available marked slots behind the building AND there is plenty of parking on the street.

In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, PCRE, PCOTC, WCR, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official Rally-O Rules and Regulations of WCR and the provisions for entry as set forth in the Rally Trial Schedule of which this entry form is a part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid. Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I (we) am (are) a family member of the dog's owner as stated and allowed in the World Cynosport Rally rules, and that I (we) shall hold PCRE, PCOTC, and WCR, including their officers, directors, employees and agents and their sponsors, harmless from any liability or claim made by dog's owner.
